5 Bidders should note that to qualify for award of the contract they are required to meet certain minimum qualifying criteria as provided in Section III (Evaluation and Qualification Criteria) of the Bidding Document, which includes but not limited to the following: – (i) experience as prime contractor in construction of at least two works similar nature and complexity ir the last five years each of minimum value of USD 8.3 million, (I) Average Annual Turnover calculated as total certified payments received for contracts in progress or completed, within the last five (5) years of

USD 13.3 million, (i) minimum amount of liquid assets and/or credit facilities net of other contractual commitments of USD 2.2 million.
